Our Sanctuary program incurred \$3,620 in expenses, with no direct corresponding revenue. This included costs of barn maintenance, blankets, and supplies for the horses in our care.

Our program received \$7,846 which was utilized in our general fund to offset the costs of both the adoption and sanctuary program. These receipts were not specifically attributable to either program as they were generated from general public awareness, outreach and fundraising.
